AGRICULTURAL SECURITY AREA PROPOSAL WITH
ADDITIONS AND MODIFICATIONS

WHEREAS, a proposal has been submitted to the Lackawaxen Township Board of Supervisors for the review of the Lackawaxen Township, Pike County, Pennsylvania Agricultural Security Area, in accordance with the provisions of the "Agricultural Area Security Law", Act of June 30, 1981, P.L. 128, No. 43, §2, and all revisions to the said statute through Act 14 of 2001 (the "Act"), a true and correct copy of which is attached hereto and made a part hereof (the "Proposal"); and

WHEREAS, in response to the Proposal, the Township Board of Supervisors has complied with and completed the procedures and considerations prescribed in Sections 5, 6, and 7 of the Act;

WHEREAS, the Proposal includes the following owners, parcels, and acreage within Lackawaxen Township, Pike County, Pennsylvania.

WHEREAS, after duly advertised public hearing and after consideration of the reports of the Township and County Planning Commissions, the Township Agricultural Area Advisory Committee and the comments from the public hearing,

NOW, THEREFORE, BE IT RESOLVED, by the Lackawaxen Township Board of Supervisors that:

Section 1. The Board of Supervisors declares and accepts the proposed Agricultural Security Area for Lackawaxen Township, Pike County, Pennsylvania.

Section 2. The Proposal and a description of the Lackawaxen Township, Pike County, Pennsylvania Agricultural Security Area shall be recorded forthwith in the Pike County Office of Recorder of Deeds, Pike County Administration Building under the list of miscellaneous documents. It shall also be filed with the Lackawaxen Township Planning Commission, the Pike County Planning Commission, and with the Pike County Land Preservation Office (c/o Pike County Office of Community Planning), Pike County, Pennsylvania.




